**License Fees:** A fee of **\$100.00** per year or any portion thereof shall be paid to the City of Park City prior to issuance of a license. Two fees are required if more than one class of license is issued. Unless renewed, all licenses expire on the 31st day of December of each year. A fee of **\$25.00** is charged on all new applications for licenses. The City will accept checks or cash. Credit Card payments can be made in person or by FAX; with a follow-up phone call. There is a \$2.50 convenience fee charged by the credit card company. **DO NOT PUT CREDIT CARD INFORMATION ON YOUR APPLICATION;** a clerk will call you for processing.
